#### AIMS OF THE MODULE

The module introduces students to the European Union, the European integration process and the EU institutional environment. It aims to develop students' understanding of the way the European Union works and how its policy output and powers affect their lives as citizens. As such, the module has three objectives. First, to give students a solid understanding of the history, institutions, and decision-making processes of the European Union. Second, to equip students with an appreciation of the principal issues and controversies which currently face the European Union, and, third, to explore and analyse the broader political and societal context in which European integration is evolving.

Europe is (once again) undergoing a period of dynamic and multifaceted change, and, it is clear that the European Union is driving these changes. Over the past decade the EU was battered by a series of inter-linked crises, including the Eurozone, Brexit, the Covid pandemic and the Russian attack on Ukraine in 2022-23. This module will seek to reference current politics and illustrate how the EU institutions are managing these important developments. From an perspective, the interaction institutional between Commission and Parliament is crucial to the trajectory of EU politics. Thus, the importance of 'getting to know the institutions' as a core objective of this module. This is particularly important as Ireland reaches the milestone of 50 years of EU membership in 2023. It is also the thirtieth anniversary of the Single European Market coming into being.

This module is one of four modules associated with the EU Erasmus Plus Jean Monnet Chair in European Integration and Jean Monnet Centre of Excellence (2020-23) at Maynooth University. As such it

benefits from Erasmus Plus funding to support the teaching of European Integration.

## **LEARNING OUTCOMES**

Having completed the module, students should understand:

- how each of the key institutions of the EU works;
- the balance of power between the major EU institutions;
- the relationship between the EU and its member states;
- the successes and limits of European integration;
- the broad constellation of issues currently shaping European society;
- how to engage with and utilize the full range of primary and secondary sources relating to EU institutions and policies.
- The main elements of Ireland's experience of 50 years of European Union membership.

#### **ORGANISATION AND ASSESSMENT**

#### **ASSESSMENT REGIME**

Annotated bibliography for Essay One – 10%

Draft of Essay One – 10%

Final submission of Essay One – 30%

End of term Examination – 50%

Assessment for this module will be via 100% continuous assessment. This will be divided into four parts. First, students are asked to produce an annotated bibliography for the first essay. This should include key references you will use for the first essay and one or two sentences explaining why you have chosen these source materials to answer the question. The annotated bibliography must be printed out and brought to class for submission by Tuesday, Week 4

(**Tuesday 20 February 2023**. It will be worth 10% of the grade for the module.)

Second, students will be asked to write a 2, 000 word essay (30% of the grade for the module) and prior to this a draft of this essay (10% of the grade). The draft should build on the annotated bibliography and be a fully realised essay. The first draft should be completed and submitted via Moodle by Friday, 10 March 2023. This timeframe will allow the lecturer to provide extensive feedback on the writing process and allow students to incorporate feedback from the draft stage into the final product. I will then hold one to one meetings with students to highlight the important elements of the feedback and what needs to be done to improve the essay. The final part of this process will see students submit the final draft of the essay by Friday 21 April 2023. This will be worth 30% of the grade. Essay titles and submission procedures will be supplied separately to this outline and placed on Moodle.

Lectures in week 2 will be devoted to learning about how to use source materials on EU politics, in learning to think about, and read and write on European integration. Guest lectures will also take place throughout the term with information provided via Moodle.

Finally, students will take an in-person examination at the end of the semester. This part of the assessment will be worth 50% of the overall grade for the module.

Some appropriate sources of information for each of the sessions in this module are listed in turn below. The **core readings** must be consulted in advance of and subsequent to each lecture. However, you are advised that these reading lists are not exhaustive. They are intended as points of departure, i.e. their purpose is to guide you in your own searches for material. Additionally, readings recommended for one lecture/topic may also be useful for others. Credit is given to you in your assessments for the location and appropriate use of

relevant material. This module is part of the EU Jean Monnet project on teaching European integration at Maynooth University.

The module will be based around weekly lectures that will take place from week 1 through to Week 12 of the spring semester. Attendance at lectures is OBLIGATORY. In addition, I will make myself available on Friday morning for one to one Teams calls or in person meetings with students, from 1000 to 1200.

#### MAYNOOTH CENTRE FOR EUROPEAN AND EURASIAN STUDIES

The module also draws upon and will engage with the activities of the Maynooth University Centre for European and Eurasian Studies (<a href="www.maynoothuniversity.ie/Europe">www.maynoothuniversity.ie/Europe</a>), an inter-disciplinary research centre devoted to analysis of and debate on Europe, and brings together faculty from the disciplines of anthropology, history, political science, and sociology as well as European Integration. The Centre is a designated EU Erasmus Plus Jean Monnet Centre of Excellence (2020-2023). Regular seminars will be held online throughout the academic year and students are very much encouraged to take part in the activities of the Centre. Among the events planned for this semester are a series examining the impact of EU membership on Ireland and a number of events focusing on the rule of law in the European Union. The first seminar takes place on Wednesday 22 February 2023 and deals with the rule of law crisis in the EU.

Because European integration is ongoing, students will need to keep themselves abreast of current events. In other words, students should take a holistic approach and not treat the subjects covered simply as self-contained units.
