



1. Introduction

Maynooth University is a public Higher Education institution, offering programmes at undergraduate, Masters and Doctoral level to students who are generally adults (though a small proportion are under 18 years at the time of initial registration). The University also conducts research and facilitates events of a marketing, sporting, cultural and educational nature on the campus which may involve students, staff and members of the wider community (both adult and children).

The safety, welfare and development of children and young people is a core objective and key priority of the University. Every member of staff has a responsibility and duty of care to ensure that every child/young person attending the University is safe and protected from harm. Maynooth University policies and procedures have been developed to promote safe environments for children, to mitigate the potential for risk to arise and to manage it safely where it does. The Policies and Procedures outlined in this Child Safeguarding Statement apply to all staff, students, volunteers, contractors and any person performing any role or function in or on behalf of Maynooth University. The Child Safeguarding Statement is informed by the following Risk Assessment.
