Note C – At the time of offering a student a place at Maynooth University the prospective student may be requested to fill in an EU Tuition Fee Form and to provide certain documents in order to verify that the student's Fee Status has been correctly determined.

The documentary evidence to be provided could include the following:

- A copy of the student's passport and IRP card where applicable.
- A letter from the Minister of Justice and Law Reform confirming the student's status [ in the case of students with refugee status, a family member of a refugee, humanitarian leave to remain in the state, permission to remain in the state following a decision not to deport, subsidiary protection with permission to reside in the state].
- A copy of a IRP card with a **Stamp 4 EUFam** stamp [in the case of family members of EU citizens]
- Copies of parents' P21/Statements of Liability for 3 of the 5 years preceding entry to your course.
- A letter from the student's school confirming periods of attendance.
