

Findings from 1st Global Survey



ABOUT THE SURVEY

- A tool to capture **OPDs' perceptions of their participation** with governments, the UN and funding agencies on a global scale
- A **monitoring tool** in line with UNCRPD: 'Nothing about us without us' motto, international cooperation and OPD representation (compare articles 33, 32 and 4.3)
- **Generating more robust evidence and learning** on what works and what are the gaps to ensure 'meaningful participation'
- A contribution to **analyse different dimensions of meaningful participation**

Dimensions of meaningful participation

Who: which groups of persons with disabilities are invited to participate?

With whom: which decision-makers engage with persons with disabilities?

Where: at which levels?

On what: which are the issues on which OPDs are consulted?

How: are preconditions for participation ensured?

When: at which stages of the policy or programme cycle are OPDs consulted?

How often: is participation regular or occasional?


How formalised: are mechanisms for participation formal or informal?

How much: what is the level shared decision-making (from information to full co-decision)?


How effective: are the views of OPDs effectively considered?

RESPONDENTS

- **7 languages** (translations from English plain language): Arabic, Chinese, English, French, Russian, Spanish and International Sign.
- **573 OPD respondents**
- From **165 countries** across all regions
- A majority of respondents (54,5%) works at the **national level**
- **Online survey**



Regions in which OPD respondents work




Level at which OPD respondents mostly work

KEY FINDINGS

- Participation of persons with disabilities, through their representative organisations, is **increasing overall...**
- ...however, **participation remains insufficient** with regards to the standards set by Article 4.3 and General Comment 7

KEY FINDINGS – ACROSS STAKEHOLDERS


- Participation of persons with disabilities is **not equal across the diverse constituencies** of the disability rights movement;
- At the level of decision makers: **significant barriers to participation in decision-making remain**, whether with governments, UN or funding agencies, and preconditions are not met (lack of accessibility and reasonable accommodation, poor attitudes and lack of knowledge);
- At the level of OPDs: **financial support remains a big challenge for OPDs to exist as representative organisations**, although 32% of OPDs reporting their funding increased or increased a lot as compared to one year ago.
- OPDs also report lacking technical and organisational capacity to engage.

KEY FINDINGS – GOVERNMENTS

- Involvement of OPDs with governments is still insufficient with a **majority** of OPDs reporting they are ***sometimes invited***.
- Across stages of the government policy and/or programme cycle, OPDs usually do not participate in **budget decisions**: **47%** of OPDs report that they are ***never*** and **19%** that they are ***rarely consulted***, in budget decisions by their government.
- Overall, **42%** of OPDs consider that their **experience** of engagement with their government is ***poor or very poor***, 44% have a mixed experience and only 13% consider it good or very good.
- Recommendations from OPDs to governments focus on the provision of **financial support to OPDs**, a demand for inclusion of ***all groups of persons with disabilities***, a call for enhanced **consideration for their views** and meaningful roles in shared decision-making, ensuring accessibility and reasonable accommodation, or access to capacity development.

KEY FINDINGS – UN AND FUNDING AGENCIES

- While **44%** of OPDs reported being **involved with the United Nations**, they are overall not familiar with their work.
- Among UN entities, **UNICEF and UNDP** are identified by OPDs as the most inclusive agencies.
- A **majority** of OPDs who do engage with the UN report that **their experience is positive**: 54% consider it *good or very good*, while 27% consider it *mixed* and 19% *poor or very poor*.
- OPDs engaged with funding agencies report positive experiences (66%), enabling access to funding and technical guidance such as for policy change.
- OPDs demand **more and accessible information** about the UN and their work, **more substantial and regular engagement** of the UN on disability issues, more engagement with OPDs, covering underrepresented groups of persons with disabilities, and with less centralised approaches.

LIMITATIONS & LEARNINGS

- **Technical issues:** limits of existing online survey tools to manage large surveys in multiple languages;
- **Limited outreach and use:** limits of centralised data collection through IDA website;
- **Accessibility issues:** related to limitations with existing online survey tools (e.g. videos), but also length of the survey or methodological choices;
- **Methodological choices:** Respondents limited to one by OPD, influencing who responds and reduced the number and diversity of responses;
- **Data analysis:** the dataset limits the possibility to disaggregate by country or type of constituency; limits to contextualisation of results considering the type of political environment in which OPDs operate;


